#### About the Henderson County Rescue Squad, Inc.:

The Henderson County Rescue Squad is a progressive organization formed in 1957 in Hendersonville, NC. Since our beginnings we have provided a variety of services which has grown to meet the needs of an ever changing community. Currently the Rescue Squad answers approximately 2800 calls for service annually ranging from emergency and non-emergency ambulance transports, standby services as well as technical rescue operations with a roster of over 90 volunteers and staff. The Rescue Squad is a certified EMT-Intermediate provider as well as being certified for the following rescue specialties: Heavy Rescue, High Angle, Swiftwater, Dive and Open Water Rescue, Agricultural Rescue, Confined Space Rescue, Trench Rescue, Winter Alpine Search and Rescue and Wilderness Search & Rescue.

#### About the Position:

In the realm of emergency services, the Emergency Medical Technician (EMT-B) must be in constant readiness and state of mind. Because any and all aspects of emergency service involve the saving of human lives, it is fundamental to the position of EMT-B that all duties and responsibilities are deemed essential at the very least. While under direct supervision of the Assistant Chief, squad officer(s) or while acting on his/her own volition, the EMT-B is responsible for performing emergency medical care while on emergency incidents, non-emergency (convalescent) transports and specialized rescue services to ill or injured persons. The EMT-B may also perform EMS prevention, general facility, apparatus and equipment maintenance, public education and other related programs and services.

#### Desired Minimum Qualifications:

- NC EMT-B with current accreditation with Henderson County Emergency Medical Services or able to obtain within 6 months of employment.
- ICS 100,200,700,800

#### Compensation:

- The hourly pay range for the position is \$9.50-\$12.50 depending on certifications (FLSA Non-Exempt, Hourly) (12 hour shifts)
- HCRS standard part-time benefits package as established by the Board of Directors
